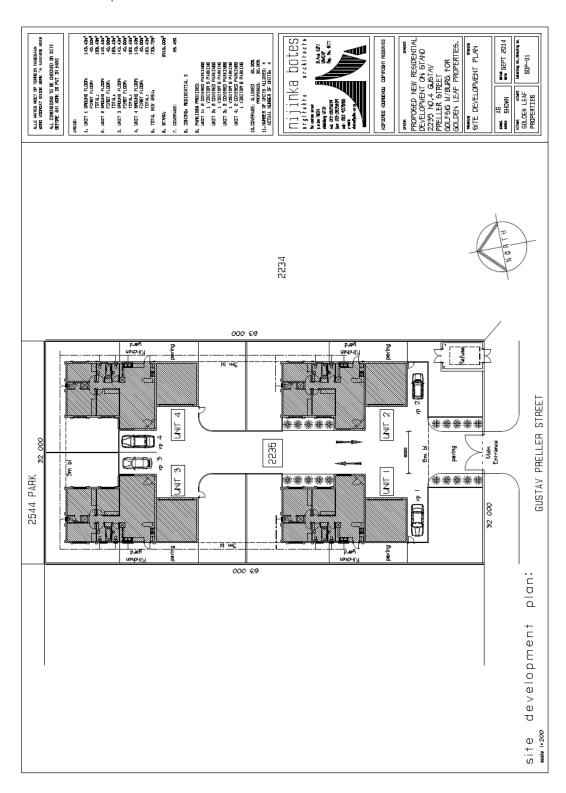






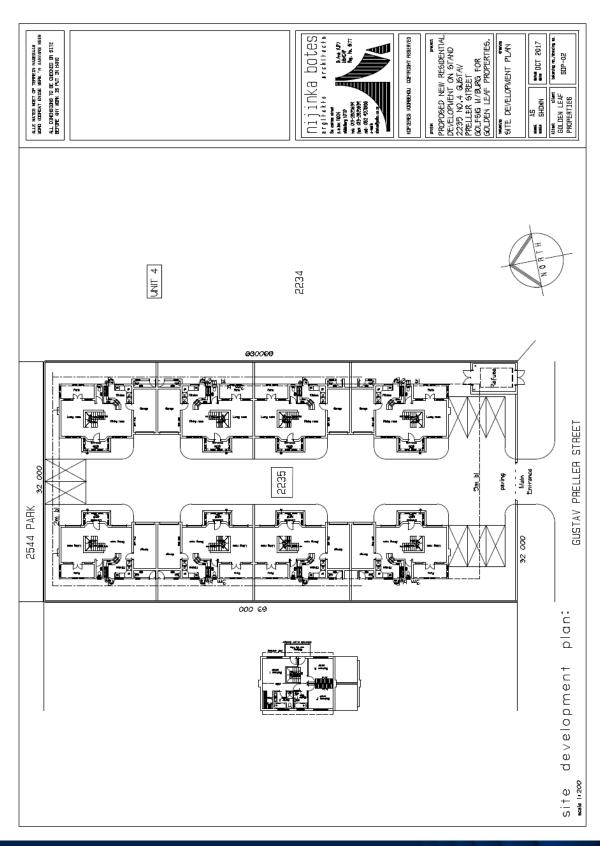
Proposed Development – 4 Units

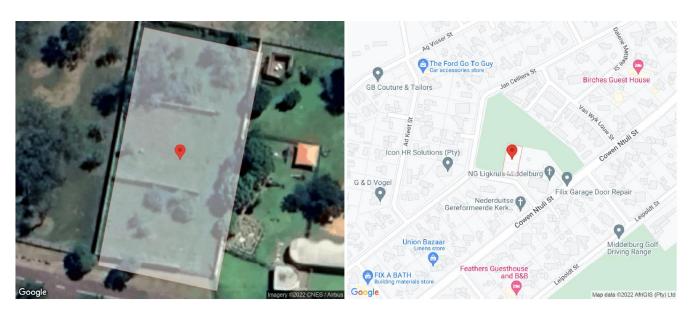
