SUMMARY OF SOME IMPORTANT RULES AND REGULATIONS:

Entry into Sabiepark is at own risk. No claims shall be made in respect of any injury, loss, accident of theft sustained within the limits of Sabiepark township.

Sabiepark is a proclaimed Private Nature Reserve. All rules and regulations pertaining to a Private Nature Reserve are applicable in this Park.

1. The speed limit in Sabiepark is 25 km/h. No reckless driving.
2. No trespassing on private property. Stay on the indicated main roads.
3. Collecting of firewood in the veld is prohibited.
4. No spotlights are permitted at night.
5. Do not disturb the animals or plants. No hunting or fishing allowed.
6. Fires are not permitted outside of braai areas specifically made for that purpose.
7. No undue loud noise is permitted.
(no loud music, animal recordings, shouting, hooting, generators (as per rules), etc.)
8. No jogging or cycling allowed.
9. No pets allowed.
10. No unsealed rifles, shotguns, cross-bows or other lethal weapons. Only unsealed hand guns allowed. Declare at the gate.
11. The facilities must be treated and utilized with respect, and left in the conditions in which they were found.
12. The South African Roads ordinances are fully applicable in Sabiepark.
13. No unauthorized usage of club facilities for non-owners are allowed.
14. The staff may not be disturbed outside of working hours.

Offenders will be prosecuted. A full list of the rules is available from the office on request.

SAMEVATTING VAN SOMMIGE BELANGRIKE REËLS EN REGULASIES

Toegang tot Sabiepark is op eie risiko. Geen eise ten opsigte van beserings, verliese, ongelukke of diefstal binne die grense van die dorpsgebied sal oorweeg word nie.

Sabiepark is 'n geproklameerde Privaat Natuurreservaat. Alle reëls en regulasies ten opsigte van private natuurreservate is in die park van toepassing.

1. Die spoedbeperking in Sabiepark is 25 km/h. Geen roekelose bestuur nie.
2. Geen betreding van private eiendom. Bly op die aangeduide dorpspaaie.
3. Optel van vuurmaakhout in die veld is verbode.
4. Gebruik van skietlampe saans is verbode.
5. Moet nie die diere of plante versteur nie. Jag en hengel is verbode.
6. Vure mag slegs gemaak word op braaiplekke spesifiek daarvoor gebou.
7. Geen lawaai of onnodige geraas toegelaat nie.
(Geen luide musiek, diere-opnames, geskreeuery, getoet, kragopwekkers (soos per reëls), ens. nie)
8. Geen draf of fietsry toegelaat nie.
9. Geen troeteldiere toegelaat nie.
10. Geen onverseelde gewere, haelgewere, kruisboë of ander dodelike wapens toegelaat nie.
Slegs onverseelde handwapens toegelaat. Verklaar by die hek.
11. Alle geriewe moet in dieselfde skoon en opgeruimde toestand gelaat word soos wat dit aangetref is.
12. Die Suid Afrikaanse padordinansies is ten volle van toepassing in Sabiepark.
13. Geen ongemagtigde gebruik van Klub fasiliteite deur nie-eienaars nie.
14. Personeel mag nie buite werksure versteur word nie.
