### **SABIEPARK OWNER ID CARDS**

On transfer of title of property in Sabiepark, ALL Sabiepark Owner ID Cards issued in the name of the Seller must be returned to Sabiepark for cancellation. Only on receipt of ALL Sabiepark Owner ID Cards issued in the name of the Seller, and on registration of the property in the name of the new owner (or registration of new shareholding in the property owner), may new Sabiepark Owner ID Cards be issued.

New Sabiepark Owner ID Cards may be issued to the buyer prior to registration, ONLY on condition that the registered owner (the seller) legally signs over all rights, privileges and usage of his property to the seller, and ONLY once ALL Sabiepark Owner ID Cards issued in the name of the Seller have been returned to Sabiepark.

A registered owner (or nominee of a registered owner) may at any time return any Sabiepark Owner ID Cards issued on his property for cancellation, and may request in writing that a new, or new, Sabiepark Owner ID Card/s be issued.

Sabiepark Owner ID Cards will only be issued in terms of our constitution, and on receipt of a written request for such by the registered owner (or nominee of a registered owner), and on receipt of two (2) ID photographs of the new card holder, and on receipt of payment of the prescribed fee.

In terms of our constitution, a registered owner who is a natural person may have Sabiepark Owner ID Cards issued to any or all of his/her direct descendants (ie spouse, children, children-in-law, grandchildren).

A registered owner who is a legal person (Company, CC, Trust, etc) may have a maximum of six (6) Sabiepark Owner ID Cards issued to any person/s so nominated by the nominee of the owner.

- 6.9 'n Geregisteerde eienaar mag 'n "Klas B" lid of lede bykomstig tot die aantal lede soos in klousule 6.2.2. gestipuleer, nomineer deur 'n jaarlikse fooi soos van tyd tot tyd deur die Komitee bepaal, per lid te betaal, met die voorbehoud dat so 'n bykomstige lid of lede familieleden (soos in klousule 6.2.1 gestipuleer) van die geregisteerde eienaar, van 'n aandeelhouer, lid, vennoot of gesamentlike eienaar, wat belange in die geregisteerde eienaarskap het, is.
- 6.9.1 In geen geval, egter, sal die maksimum aantal "Klas B" lede van enige enkel geregisteerde eienaar die aantal van elf (11) oorskrei nie.

Tans beloop die jaarlikse fooi R 550-00, BTW ingeslote, per addisionele kaart. Die fooi sal teen die rekening gedebiteer word. Die betrokke jaar is 'n kalenderjaar en die kaart moet asseblief met vervaldatum aan die kantoor terugbesorg word.

## **RE: ADDITIONAL SABIEPARK ID PHOTOCARDS.**

At the Annual General Meeting of 13 July 2002 it was determined that additional annual ID cards may be issued to family members (clause 6.2.1) with reference to clause 6.9 of the Constitution of the Property Owners Association:

6.9 A registered owner may nominate a "Class B" member or members in excess of the maximum number as stipulated in clause 6.2.2 by paying an annual fee per additional member, as determined from by the Committee from time to time, with the provision that such additional member or members shall be family members (as defined in 6.2.1) of the registered owner, or of a shareholder, member, partner or joint owner, having an interest in the registered owner.

6.9.1 In any and all cases the maximum number of "Class B" members for any one registered owner will not exceed eleven (11).

The fee currently is R 550-00, VAT included, per additional card. The fee will be debited against your account. The year concerned is a calendar year and the card must please be returned to the office on expiry.
